In the absence of comments by 17 July 2023, to the President of the Council's email dated 10 July 2023, Mr. James Spillane, nominated by the Government of the United States, has been appointed as Member on the Air Navigation Commission to succeed Mr. Donald Ward, with effect from 17 July 2023.

In the absence of comments by 1 September 2023, to the President of the Council's email dated 25 August 2023, Mr. Per Anders Leufgård, nominated by the Government of Norway, on behalf of the Governments of Denmark, Estonia, Finland, Iceland, Latvia and Sweden, had been appointed as Alternate to Mr. Bernt Tore Larsen on the Air Navigation Commission, with effect from 25 September 2023.
