Thirteenth Meeting of the Executive Committee, Wednesday, 5 October 2022

At its Thirteenth Meeting on Wednesday, 5 October 2022 at 1800 hours, the Executive Committee resumed and completed its consideration of Agenda Item 28 (Other high-level policy issues to be considered by the Executive Committee).

The Executive Committee subsequently considered and completed its work on Agenda Item 26 (ICAO Civil Aviation Training and Capacity Building). The Committee thereafter reviewed and approved the respective draft texts of the Reports to the Plenary for Agenda Items 11 (A41-WP/641), 12 (A41-WP/618), 16 (A41-WP/601), 19 (A41-WP/639), and 20 (A41-WP/609).

Fourteenth Meeting of the Executive Committee

At the Fourteenth meeting of the Executive Committee held on Thursday, 6 October 2022 at 0900 hours, the Committee reviewed and approved the respective draft texts of the Reports to the Plenary for Agenda Items 14 (A41-WP/613), 15 (A41-WP/612), 22 (A41-WP/615) and 23 (A41-WP/614). The Committee also reviewed and approved the draft texts of the Reports to the Plenary for Agenda Items 13 (A41-WP/619) and 21 (A41-WP/617), on the understanding that the Committee would return to those elements of the Reports in need of further refinement, as soon as practicable.

Health and Safety

Given the increased number of COVID-19 cases in the ICAO Headquarters, delegates are reminded that wearing face masks is highly recommended, in particular when physical distancing of at least 1 meter cannot be observed.
