Yesterday's meetings, Thursday, 29 September 2022

First Meeting of the Legal Commission

The Legal Commission, at its first meeting on Thursday, 29 September 2022, at 0900 hours, presided by its Chairperson, Dr. Jonathan Aleck (Australia), elected Ms. Susanna Metsälampi (Finland) and Mr. Peter Amaleboba (Ghana) as its First and Second Vice-Chairperson respectively.

The Commission completed consideration of Agenda Items 40 and 41.

First Meeting of the Technical Commission

The Technical Commission held its first meeting on Thursday, 29 September 2022, at 0900 hours, with Mr. Raúl Medina Caballero (Spain) as its Chairperson. The Commission elected Mr. Sulaiman Almuhaimedi (Saudi Arabia) as First Vice-Chairperson, and Mr. Luiz Ricardo de Souza Nascimento (Brazil) as Second Vice Chairperson.

Under Agenda Item 29 (Annual Reports of the Council to the Assembly for 2019, 2020 and 2021), a presentation was made by Mr. Stephen Creamer, Director, Air Navigation Bureau, on ICAO activities in the area of safety and air navigation. The Technical Commission noted those parts falling within its field of competence of the Annual Reports of the Council to the Assembly for 2019, 2020 and 2021 and the Supplement for the first half of 2022.

The Technical Commission also considered and completed its work on Agenda Item 29 (Annual Reports of the Council to the Assembly for 2019, 2020 and 2021) and began consideration of Agenda Item 30 (*Aviation Safety and Air Navigation Policy*), with working papers under groups 1, 2 and part of group 3. At its next meeting, the Technical Commission will resume consideration of Agenda Item 30, with the remainder of working papers under group 3, and begin consideration of Agenda Item 31 (*Aviation Safety and Air Navigation Standardization*).

Third Meeting of the Executive Committee

At its Third Meeting, held on Thursday, 29 September 2022 at 1400 hours, the Executive Committee continued its consideration of Agenda Item 17 (Environmental Protection – Climate Change). On the basis of the ensuing deliberations, the Committee expressed its overwhelming support for the revised Resolution, *Consolidated statement of continuing ICAO policies and practices related to environmental protection – Climate Change,* as presented in A41-WP/369, and agreed to recommend that said Resolution be forwarded to the Plenary for adoption.

The Committee also commenced its consideration of Agenda Item 18 (Environmental Protection – CORSIA), on the basis of two papers presented by the Council (A41-WP/370 and A41-WP/371), and related papers.

The Committee had not completed its consideration of this item, and as such, agreed to continue its discussion at its next (fourth) meeting, which started its deliberations at 1800 hours on Thursday, 29 September 2022*.
