# Fourth Meeting of the Plenary

At the Fourth Plenary Meeting, held on Saturday, 1 October 2022, at 0900 hours, Parts I and II of the election of the Council were conducted under Agenda Item 5. Before proceeding to the vote, the Chairperson of the Credentials Committee (Equatorial Guinea), presented the oral interim report of the Committee, regarding the credentials that had been received to date.

With 170 States voting and 170 votes cast, the number of votes required for election in Part I was at least 86. There were 11 candidates for 11 seats in this Part, and 10 were elected as follows: Australia, Brazil, Canada, China, France, Germany, Italy, Japan, United Kingdom, and United States.

In Part II, there were 12 candidates for 12 seats, and 12 were elected. With 171 States voting and 171 votes cast, the number of votes required for election in Part 2 was at least 86. The following States were elected: Argentina, Austria, Egypt, Iceland, India, Mexico, Nigeria, Saudi Arabia, Singapore, South Africa, Spain, and Venezuela (Bolivarian Republic of).

The President of the Assembly announced that the Part III of the election of the Council would be held at the Sixth Plenary Meeting on Tuesday, 4 October 2022, at 1400 hours. In noting that one additional seat remained vacant following the election in Part I, the Assembly decided to amend the decision taken during the first Plenary meeting on the maximum number of candidates to be elected in each part (A41-WP/2, refers), such that the vacant seat on Part I would be reallocated to Part III. It was therefore agreed that up to 14 candidates could now be elected to the Council under Part III. The deadline for notifications of candidature, which should be submitted in writing to the Secretary General, was set at 1200 hours on Monday, 3 October 2022.

The meeting adjourned at 1200 hours.

### Fifth Meeting of the Plenary

The Fifth Plenary Meeting, held on Saturday, 1 October 2022, at 1400 hours, continued with Agenda Item 8 (Statements by Delegations of Member States), with general statements delivered by the Delegations of: Republic of Korea, Egypt, Ghana, Chile, Lebanon, Zimbabwe, Oman, the United Republic of Tanzania, Bahrain, Ethiopia, United Arab Emirates, Cameroon, Niger, Jamaica, Georgia, and Bangladesh. A statement was also made by the observer from the African Union.

The meeting adjourned at 1550 hours.

### Fifth Meeting of the Executive Committee

At its Fifth Meeting, held on Saturday, 1 October 2022 at 1600 hours, the Executive Committee considered and completed its work on Agenda Item 12 (Outcomes of the High-level Conference on COVID-19).

At the time of adjournment at 1715 hours, as the Committee had not completed all items on its order of business, it agreed to continue its deliberations on the remaining items at its sixth meeting, which started its deliberations at 1800 hours on Saturday, 1 October 2022, beginning with Agenda Item 13 (Facilitation Programmes).

# Second Meeting of the Economic Commission

The Economic Commission, at its second meeting on Saturday, 1 October 2022 at 1600 hours, resumed its work and completed its consideration of:

• Agenda Item 36, Economics of Airports and Air Navigation Services — Policy, based on WPs 11, 12 and related papers;

• Agenda Item 37, Aviation Data – Monitoring and Analysis, based on WPs 14, 15, and 16 and related papers; as well as

• Agenda Item 38, Economic Development of Air Transport, based on WP 17 and related papers.

The Commission agreed to continue its work on Agenda item 39, Other issues to be considered by the Economic Commission, at a third meeting, the date and time of which will be conveyed to the delegates once determined.
