Sixth Meeting of the Executive Committee, Saturday 1 October 2022

At its Sixth Meeting, held on Saturday, 1 October 2022 at 1800 hours, the Executive Committee considered and completed its work on Agenda Item 13 (Facilitation Programmes). The meeting adjourned at 2100 hours.

Yesterday's Meetings, Monday 3 October 2022

Seventh Meeting of the Executive Committee

At its Seventh Meeting, held on Monday, 3 October 2022 at 0900 hours, the Executive Committee commenced its consideration of Agenda Item 14 (Aviation Security - Policy), completing its deliberations in relation to working papers under Batches 1 (GASeP), 2 (Regulatory Policy), 3 (Human Factors, Security Culture and Insider Threat), 4 (International Cooperation) and 5 (Aviation Security Resolution).

As the Committee had not concluded its consideration of the final batch (Aviation Cybersecurity) of working papers under Agenda Item 14 at the time of its adjournment at 1215 hours, the Committee resumed its deliberations in that regard during its Eighth meeting, on Monday, 3 October 2022, at 1400 hours.

Second Meeting of the Administrative Commission

The Administrative Commission held its second and final meeting on Monday, 3 October 2022 at 0900 hours during which a Draft Report on Agenda Items 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55 and 56 was considered. The Commission recommended that the Draft Report, with some minor amendments, be referred to the Plenary for approval of the Report and adoption of the Draft Assembly Resolutions.

In closing the meeting, the Chairperson thanked the Commission and Secretariat staff for their contributions and commended the efficient and effective proceedings which helped the Commission to accomplish its work. The meeting closed at 0922 hours.

Third Meeting of the Economic Commission

The Economic Commission, at its third meeting held on Monday, 3 October 2022 at 1030 hours, resumed its work and completed its consideration of Agenda item 39 (Other issues to be considered by the Economic Commission).

Eighth Meeting of the Executive Committee

The Committee resumed its consideration of Agenda Item 14 (Aviation Security - Policy) at its Eighth meeting at 1400 hours on Monday, 3 October 2022, and completed its deliberations thereon. The Committee subsequently considered and completed its work on Agenda Items 15 (Audit Programmes – Continuous Monitoring Approach), 11 (Annual Reports of the Council to the Assembly for 2019, 2020 and 2021), 19 (Multilingualism at ICAO) and 20 (Increasing the Efficiency and Effectiveness of ICAO). The meeting adjourned at 1655 hours.

It was noted that the Ninth meeting of the Executive Committee would be held at 1800 hours, on Monday, 3 October 2022.

Health and Safety

Given the increased number of COVID-19 cases in the ICAO Headquarters, delegates are reminded that wearing face masks is highly recommended, in particular when physical distancing of at least 1 meter cannot be observed.
