Ninth Meeting of the Executive Committee, Monday, 3 October 2022

At its Ninth Meeting, held on Monday, 3 October 2022 at 1800 hours, the Executive Committee considered and completed its work on Agenda Items 21 (United Nations 2030 Agenda - Sustainable Developments Goals (SDGs)), 22 (Resource Mobilization and Voluntary Funds), and 23 (Innovation in Aviation).

The Committee also commenced consideration of Agenda Item 27 (Measures towards Gender Equality at ICAO and the Global Aviation Sector by 2030), and while it completed its deliberations in relation to working papers under Batch 1 (Advancing Gender Equality in ICAO and the aviation sector), it did not conclude its consideration of the remaining working papers under this item. The Committee resumed its consideration of Agenda Item 27 during its Tenth Meeting on Tuesday, 4 October at 1800 hours.

Yesterday's Meetings, Tuesday, 4 October 2022

Third Meeting of the Legal Commission

The Legal Commission held its Third and final meeting on Tuesday, 4 October 2022 at 0900 hours during which it considered and endorsed the Draft Report contained in A41-WP/606, A41-WP/607, and A41-WP/608. The Commission recommended that the Draft Report, with some minor amendments, be referred to the Plenary for approval of the Report.

Fourth Meeting of the Technical Commission

The Technical Commission held its Fourth meeting on Tuesday, 4 October 2022 at 0900 hours, and completed its review of Draft Reports and approved Report materials on Agenda Item 29 (Annual Reports of the Council to the Assembly for 2019, 2020, and 2021), Agenda Item 30 (Aviation Safety and Air Navigation Policy), Agenda Item 31 (Aviation Safety and Air Navigation Standardization), Agenda Item 32 (Aviation Safety and Air Navigation Regional Implementation Coordination Mechanisms) and Agenda Item 33 (Other issues to be considered by the Technical Commission).

Sixth Meeting of the Plenary

At the Sixth Plenary Meeting, held on Tuesday, 4 October 2022, at 1400 hours, Part III of the election of the Council was conducted under Agenda Item 5. It was recalled that in light of the decision of the Assembly to reallocate the vacant seat on the Council from Part I of the election to Part III, there were 14 vacant seats under Part III.

With 175 States voting and 175 votes cast, the number of votes required for election in Part III was at least 88. The 14 candidates elected included: Bolivia (Plurinational State of), Chile, El Salvador, Equatorial Guinea, Ethiopia, Ghana, Jamaica, Malaysia, Mauritania, Qatar, Republic of Korea, Romania, United Arab Emirates, and Zimbabwe. It was highlighted that in the 78-year history of ICAO, it was the first time that Mauritania, Qatar, and Zimbabwe had been elected to the Council.

The remainder of the meeting was devoted to Agenda Item 8, with general statements being delivered by the Delegations of: Thailand, Mauritania, Bolivia (Plurinational State of), Burundi, Namibia, Seychelles, Democratic Republic of the Congo, Belize, Eswatini, Samoa, Maldives, Tuvalu, Pakistan, Iraq, Indonesia, Nauru, and Eritrea. World Health Organization (WHO), an observer, also delivered a statement to the Assembly.
