Tenth Meeting of the Executive Committee, Tuesday, 4 October 2022

At its Tenth Meeting held on Tuesday, 4 October 2022 at 1800 hours, the Committee resumed and completed consideration of Agenda Item 27 (Measures towards Gender Equality at ICAO and the Global Aviation Sector by 2030).

The Committee subsequently commenced its consideration of Agenda Item 28 (Other high-level policy issues to be considered by the Executive Committee). While the Committee completed its consideration of the working papers under Batch 1 (Infractions of the Convention on International Civil Aviation by the Republic of Belarus), it did not conclude its consideration of the remaining working papers under this item. It was understood that the Committee would resume its consideration of Agenda Item 28 at its Eleventh Meeting, scheduled on Wednesday, 5 October at 0900 hours.

The meeting adjourned at 2100 hours.

Yesterday's Meetings, Wednesday, 5 October 2022

Eleventh Meeting of the Executive Committee

At its Eleventh Meeting held on Wednesday, 5 October 2022 at 0900 hours, the Committee continued its deliberations on Agenda Item 28 (Other high-level policy issues to be considered by the Executive Committee), beginning with working papers under Batch 2 (Infractions of the Convention on International Civil Aviation by the Russian Federation).

Invoking Rule 47 of the Standing Rules of Procedure of the Assembly, Russian Federation, seconded by Belarus and Eritrea, moved to request a secret ballot vote in relation to A41-WP/430. There being no objection to the motion of Russian Federation, and in light of the ensuing debate, the Committee proceeded to conduct a secret ballot vote on the question of whether the Committee supported the actions proposed in A41-WP/430 as presented by the Council. With 124 votes cast, of which 82 were in favour, 15 opposed and 27 abstentions, the vote was carried in the affirmative, indicating the Committee's support for the actions in A41-WP/430. The Committee suspended its deliberations on the remaining working papers in Batch 2 under Agenda Item 28, and agreed to return to this Agenda Item at its next meeting.

As such, the Committee turned to consider the remaining items on its Order of Business, completing its consideration of Agenda Item 25 (Technical Cooperation – Policy and Activities), and commencing its deliberations on Agenda Item 24 (ICAO's Technical Assistance Programme and Implementation Support). At the time of adjournment, as the meeting had not completed its consideration of Agenda item 24, it was agreed that next meeting of the Committee would resume its discussion in this regard.

The meeting adjourned at 1155 hours.

Twelfth Meeting of the Executive Committee

At the Twelfth meeting of the Executive Committee, held on Wednesday, 5 October 2022 at 1400 hours, the Committee resumed and completed its consideration of Agenda Item 24 (ICAO's Technical Assistance Programme and Implementation Support).

The Committee also resumed its consideration of the remaining two working papers in Batch 2 (Infractions of the Convention on International Civil Aviation by Russian Federation) under Agenda Item 28 (Other high-

level policy issues to be considered by the Executive Committee). Acting in accordance with Rule 46 of the Standing Rules of Procedure of the Assembly, Colombia moved to proceed to a vote by show of hands in

relation to A41-WP/455 and A41-WP/456, which was seconded by Mexico. Also pursuant to Rule 46, Russian Federation, supported by Belarus, requested that said vote be conducted by a roll-call. Following further discussion, and in line with the established procedures, the Committee proceeded to a roll-call vote on the question of whether the Committee supported the actions proposed in A41-WP/455 and A41-WP/456, as presented by Russian Federation. Of the 97 votes declared, of which 8 were in favour, 62 opposed and 27 abstentions, the vote was not carried, indicating that the actions in A41-WP/455 and A41-WP/456 were not supported by the Committee.

The Committee subsequently began consideration of the working papers under Batch 3 (Unannounced Missile Launches); however, it was unable to conclude its deliberations in the time remaining. The Committee therefore agreed to resume its consideration of Agenda Item 28 at its thirteenth meeting scheduled later that day, at 1800 hours.

The meeting adjourned at 1700 hours.

Fourth Meeting of the Economic Commission

The Economic Commission held its Fourth and final meeting on Wednesday, 5 October 2022 at 1400 hours during which it considered and endorsed the Draft Report contained in A41-WPs/635, A41-WP/636, A41-WP/637, A41-WP/638, A41-WP/642, A41-WP/645 and A41-WP/646. The Commission recommended that the Draft Report be referred, as amended, to the Plenary for approval.
